CASE STATEMENT

The construction of a permanent church has been the dream of St. Peter the Apostle parish from its earliest days. As the parish began, a church was built to temporarily meet the worship needs of parishioners. More than 50 years later, the parish continues to use this temporary structure as their permanent home.

Through the work of the Foundations for the Future Committee, the advice of our project architect and consultation with the diocese, it was determined that the current church cannot be renovated, as it was built as a temporary structure and will not meet current building requirements. Now is the time for the parishioners of St. Peter the Apostle to embark on a building effort to make reality a new, functional and permanent worship space that will meet both current and future needs of the community.

VALUE STATEMENTS

The value statements below are offered as a summary of desires heard from the constituents who participated in the Case Statement Process through personal interviews and focus groups. As St. Peter the Apostle moves forward with a Capital Campaign, it is important to ensure the following value statements are protected and enhanced. The value statements are:

- We will realize the dream for the parish of the construction of a permanent church building. This dream had its foundation in 1957 when a temporary structure was built.
- We believe in and will continue to maintain the strong community atmosphere at St. Peter the Apostle.
- We will foster an environment that promotes engagement and collaboration.
- We will welcome current, former and new parishioners equally into our faith community.
- We will remember the day-to-day benefits of this parish, the services it offers, the opportunity to participate in worship, and the peace it gives us.

To ensure the above-referenced value statements for St. Peter the Apostle are maintained, the following capital initiatives are recommended and under consideration, pending funding:

CONSTRUCT A NEW CHURCH

- Create a functional worship space with a warm, home-like feeling that incorporates elements such as a central aisle and statues.
- Ensure the church has proper systems in place that will allow parishioners to fully participate in liturgy and be comfortable sitting, standing and kneeling regardless of the weather or season.
- Construct physical space that is accessible to people of all abilities.
- Build physical structures to support an already strong community that includes:
 - A Narthex that allows for members of the parish to gather following mass, as well as promote events that are happening in the parish.
 - Gathering space to hold receptions following mass and other events or meetings.
 - A Eucharistic Chapel
 - Sufficient storage for church needs, as well as the various ministries.
 - Meeting space for various ministries.
 - Additional support spaces including multiple bathrooms, bride's room and choir space.

FREQUENTLY ASKED QUESTIONS

WHAT IS A CAPITAL CAMPAIGN?

A capital campaign is an intensive philanthropic effort designed to raise a specific sum of money within a defined time period to meet the specific project needs of an organization. During a capital campaign, the community is asked to make a gift or financial pledge over a period of time with dollars above and beyond current giving (i.e., Sunday collections).

HOW MUCH MONEY DO WE NEED TO RAISE?

The funding goal approved by Fr. Slawek and the campaign leadership for the **capital campaign is \$2.25 million**. With the addition of current savings and interest of \$2 million, projected savings and interest income of the parish over the next three years of \$1.2 million, and a generous gift of \$1.2 million from the parish's lead donor, the **overall project goal is \$6.65 million**.

WHO DECIDED WHAT PROJECTS SHOULD BE ACCOMPLISHED?

Collectively, the parishioners of St. Peter the Apostle provided the input. Beginning in the summer of 2013, parishioners were invited to participate in campaign preparation in one of three ways: attending a personal interview, attending a focus group, and/or completing an in-pew survey. The responses and information were gathered and analyzed by Laurus Strategies, and recommendations were provided in a report presented to parish leadership and the Foundations for the Future Committee, in March of 2014. Based on the recommendations contained in this report and the wishes of the community as expressed during campaign preparation, the committee discerned the scope of the project.

WHEN WILL CAMPAIGN IMPROVEMENTS BEGIN?

It is the **goal to break ground in two to three years, pending the amount of pledges and donations** that are collected for this initiative. We invite fellow parishioners to make gifts and pledges payable up to a three-year time period to make the dream of a new church a reality. Construction can begin as soon as the parish has the financial resources in place to accomplish this project.

WHAT WILL THE CHURCH LOOK LIKE?

Components of the church have been discussed (narthex, gathering space, chapel, etc.), but the look and the feel of the church are still being determined as we are currently in the planning phase.

WHY ARE WE BUILDING AND NOT RENOVATING?

After reviewing options with the architect, Dante Domanella, and consultation with the Diocese, we concluded that there was no viable renovation option. Given the needs of the parish for worship and gathering space, the current building is structurally inadequate and cannot be renovated.

HOW MUCH SHOULD I GIVE?

There is no specific amount set for each household. We request "equal sacrifices, not equal gifts," which respects the financial obligations and abilities of each household. Your commitment to the campaign is an expression of your faith and love for each other and your parish community.

IS A GIFT TO THE CAMPAIGN SEPARATE AND "ON TOP OF" MY OFFERTORY GIVING?

Yes. A gift to the campaign would be separate and above and beyond your offertory giving. Your offertory, whether given on a weekly, monthly or annual basis, provides the funds necessary to continue to serve the daily needs of the parish.

IS MY CONTRIBUTION TO THE CAMPAIGN TAX DEDUCTIBLE?

St. Peter the Apostle is a registered 501(c) 3 organization. In accordance with Internal Revenue Service guidelines, as no goods or services are being provided in return for this contribution, all or part of this gift may be tax deductible as a charitable contribution. Please consult your tax advisor.

WHAT HAPPENS IF WE MAKE A PLEDGE AND OUR INCOME CHANGES?

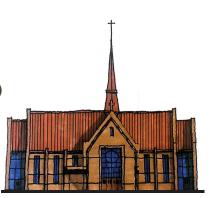
If your financial situation should change, please meet with Fr. Slawek to discuss and re-evaluate your pledge.
